Dividend Rates

For the quarter ending June 30, 2026, the Allegheny-Ludlum Brackenridge Federal Credit Union has paid the following nominal, dividend rates on share accounts on a "day-of-deposit to day-of-withdrawal" basis. In addition the Annual Percentage Yield is shown below:

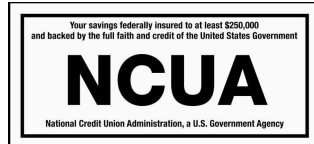
0.10% Nominal Dividend Rate on daily share balances of \$100.00 - 5,000.00 with an Annual Percentage Yield of 0.10%

0.50% Nominal Dividend Rate on daily share balances of \$5,000.01 to \$25,000.00, with an Annual Percentage Yield of 0.50%

0.75% Nominal Dividend Rate on daily share balances of \$25,000.01 to \$75,000.00 with an Annual Percentage Yield of 0.75%

1.00% Nominal Dividend Rate on daily share balances over \$75,000.01 with an Annual Percentage Yield of 1.00%

Please note that no dividends are paid on accounts which have a daily share balance under \$100.00.
